

The undersigned, "owner" of land located within the Gravois Arm Sewer District of Morgan County, Missouri, seeks sewer service availability at the above property and agrees to the following:

 To be connected to the District's sewer system, I agree to tender the sum of equal to the uniform contribution to construction and the direct cost incurred by the District to provide a tap for connection to the District wastewater system and for inspection of the service lines and grinder pump to be installed by the owner.

2. I also tender the standard security deposit for the connection which is <u>\$</u>. This security deposit shall be refunded to owner at the time of termination of the connection or on sale of the property if the final billing is paid.

3. The connection charge for the tap is \$400 which includes the actual cost of the collar and shut-off valve and the inspection of the service line installed by the landowner. Any additional costs for materials and/or labor will be the customer's responsibility. The uniform contribution by all customers for the collection and treatment system is \$1,000. I understand the charge to me will be as provided in the District's standard resolution for sewer availability and that a copy of the same including Appendix A, (the summary of all charges) may be obtained at the District office during business hours.

4. If the connection is built to District specifications and certified by the District's engineer and installation inspected and approved by the District, the District will assume responsibility for maintenance of the grinder pump and the line between the grinder pump and the District's collector mains. The line between the house line which moves wastewater from the house to the grinder pump remains the property and the maintenance responsibility of the landowner.

5. This application is accepted by the District if the District voluntarily makes the service available to the applicant.

6. So long as sewer service is made available at the owner's premises, the District shall have an irrevocable license to enter the premises at reasonable times to inspect the sewer facilities and to make necessary repairs to District facilities.
